# **Charts with names 35 characters or longer in ioControl, OptoControl, ioTerminal, and OptoTerm**

### **SYMPTOMS**

From debug mode, the View Messages (ioControl and ioTerminal) and View Errors (OptoControl and OptoTerm) windows incorrectly displays chart names that are 35 characters or longer.

### **CAUSE**

The problem is caused by the Opto 22 files ioCom.dll for ioControl and ioTerminal, and OptoCom.dll for OptoControl.

### **WORKAROUND**

Rename the chart name so that it has fewer than 35 characters.

### **RESOLUTION**

Opto 22 has resolved this issue.
