## **SYMPTOMS**

A SNAP-PAC-R1 control engine with an ioControl strategy that has persistent variables or variables with the 'Initialize on strategy download' attribute, may exhibit corrupt data if counters or data logging is configured.

## **CAUSE**

The ioControl persistent variables are stored in the same area of RAM as the digital counter data and the data logging feature data.
